The following analysis is for the one measure appearing on the ballot for the statewide election occurring on June 14, 2016. This publication is required by section 16.1-01-07 of the North Dakota Century Code to enable voters to become familiar with the effect of proposed measures. Analysis of Referred Measure No. 1

Referred Measure No. 1 was placed on the ballot by petitions circulated by a sponsoring committee to refer Senate Bill No. 2351, passed by the 2015 Legislative Assembly. Senate Bill No. 2351 would allow the ownership or leasing of up to 640 acres of land for the operation of a dairy farm or swine production facility by a domestic corporation or limited liability company. Senate Bill No. 2351 would also require the agriculture commissioner to develop reporting and monitoring rules to ensure compliance.

Voting "YES" means you approve Senate Bill No. 2351 as summarized above. Voting "NO" means you do not approve Senate Bill No. 2351 as summarized above.
